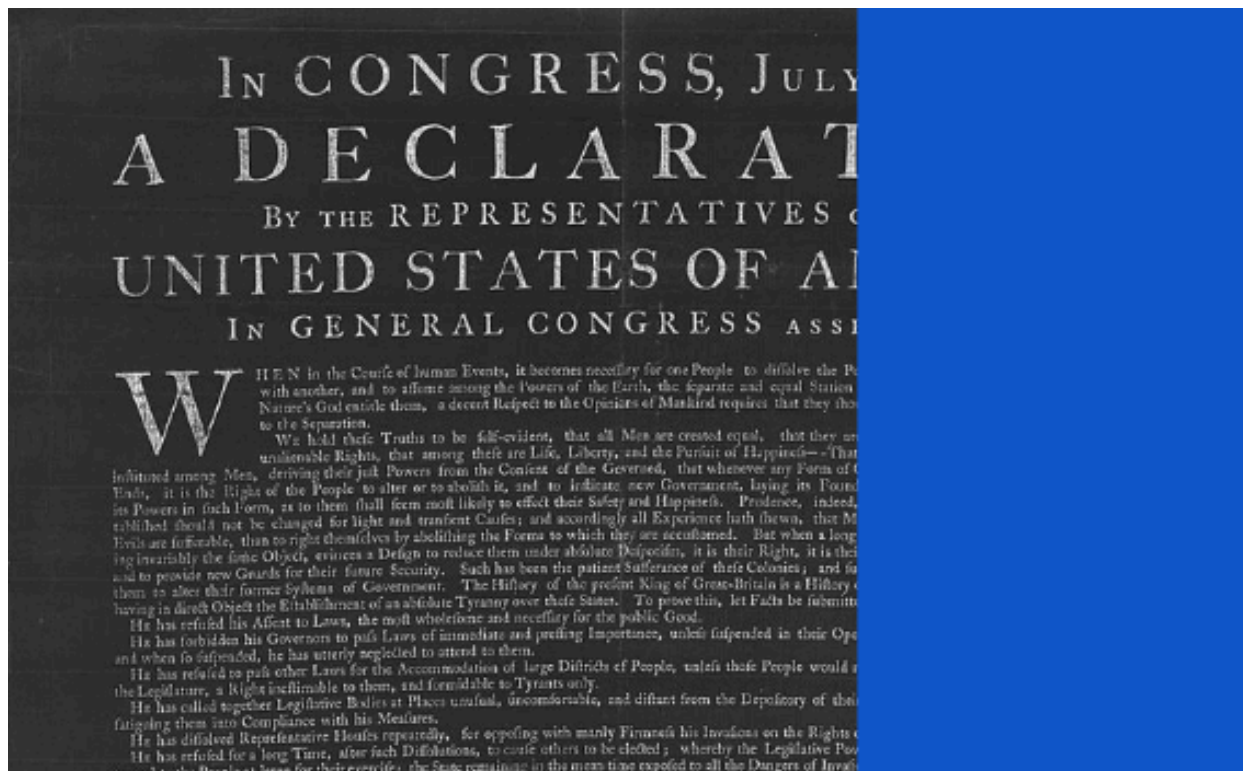

# Next Step Checklist - “jus soli”

---



## Political Status Next Steps Checklist

Please read this entire guide before beginning. Sometimes, people think they know what to do next without using the checklist and find themselves stalled at various points. Using this guide and checklist along with our video will prevent these challenges and make this process streamlined. **Nothing is to be considered legal or tax advice.** We share learnings from our community with each other and others who are looking to become American State Nationals and live as private, unincorporated and exempt Americans.

### STEP 1

**Upon receipt of completed/mailed documents:**

**Items you will need:**

- Downloaded and printed documents.
  - A package of sticky notes; you will add notes to each page for autographing.
  - Red ink pen.
  - Red ink pad (this is for your thumbprint next to your autograph). The red thumbprint for Political Status paperwork signifies that you are a living man or woman.
  - Blue ink pen.
  - Small package of wet wipes; this is to remove the ink from your thumb.
  - (Two) 2x2 pictures with a white background. Just like what you'd find on a passport. These are used on witness statements and for credential cards.
  - 8.5 x 11.5 manilla envelope if you are publishing your paperwork with your county or State of Alaska
  - A small package of letter envelopes for your notices to be mailed

### STEP 2

**Political Status Documents for Notarizing**

- Make sure you have all of the documents below shown in bullet points and separated.
- Add a photo to your witness forms. Your friends/family will use your photo and information on the form to verify that you are who you say you are.
- Get your witness forms signed by those who have known you; they are verifying that you are the person you say you are. You can notarize your documents with them or while they are doing their part for you.
- Please note:** you cannot submit your paperwork for publishing and recording until your witness forms are complete. You are not a declared American State National until you have a minimum of the two witness statements and the Declaration of Political Status Act of 1779 for your prosperity account. If you are low on cash; regarding notarizing costs, do the minimum; don't wait.
- Get the rest of the forms prepared for being autographed and notarized. You can get your paperwork notarized without the witness forms.

All the above is complete! Move to Step 3.

- Declaration of Political Status
  - Declaration of Political Status Act of 1779
  - Two Witness Statements (one for each of your witnesses to sign)
  - Deed of Reconveyance
  - \*Deed of conveyance (**ONLY if born in another country**)
  - Certificate of Assumed Name
  - Act of Expatriation JOHN ANDY DOE
  - Act of Expatriation JOHN A. DOE
  - Act of Expatriation JOHN DOE
  - Foreign Sovereign Immunities Act
  - Cancellation of all Prior Powers of Attorney
  - DNA Paramount Claim
  - Common Carry (only if joining Assembly)

### STEP 3

**Preparing for notarizing your documents. Since you will be signing/autographing with a witness who will verify who you are it's important to know the basics regarding how you will autograph each page.**

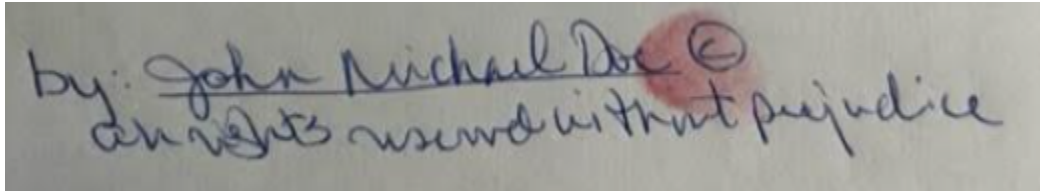
**Distinguishing yourself as an American and utilizing your autograph, copying and all rights reserved. You will note that all of your documents already have the copyright sign listed for you as well as All Rights Reserved.**

- As Americans, we autograph as opposed to signing. But, for the purposes of this document we will use both terms as the same thing.
- Wherever you see a signature option you can now begin to autograph with a by:\_\_\_\_\_ which means a "by line."
- We use our copyright; because part of our paperwork assures our copyright.
- Underneath our signatures/autographs we write All Rights Reserved. We do this on everything because it protects us against undisclosed contracts and fraud.
  - You can use this on all checks
  - On credit card signatures
  - Buying and selling a home. (I did and didn't have a single issue)
  - Opening up bank accounts
- You can also use UCC1-308 instead of All Rights Reserved. Which means it reserves all of your American Common Law Rights.

Your thumbprint could be much larger than the one shown but it should give you an idea of its placement. The placement of the thumb is key. You don't want your thumbprint in the middle of your signature or in some odd place on the page. You want it touching the last letter of your autograph.

You will be using 3 separate types of autographs for your political status paperwork. **Take note of the 3 separate styles.**

1. One is in blue and the name is printed; just like we did in kindergarten. **John Michael Doe**

2. One is in red but in cursive; all deeds are autographed this way.

*John Michael Doe*

3. The last is in blue and in cursive. All letters, all credit cards etc are autographed in blue. 95% of your autographs will be in blue except for this paperwork.

*John Michael Doe*

## STEP 4

Take out your sticky notes as you will be using the sticky notes to denote your autograph example for each page. This is where things get VERY specific. However, if something is done incorrectly it's really not a big deal. It's the "intent" not whether something is right or wrong. Plus, if you ever have a mistake all you need to do is reprint, re-notarized and it's done. Many of us have small errors, strike throughs etc. It's not a big deal at all.

Having sticky notes placed on each document will make this a breeze! You will just follow what the sticky note says to do. Your copyright symbol and All Rights Reserved are put in place for you.

We will break your paperwork into groups for ease of signing. Once you have created the sticky note and attached what the autograph will look like onto the document you can check it off the list!

## STEP 5

Getting your documents notarized. Determine where you will go. We recommend the free version as it will save you money and this should be a service offered for free at your bank or credit union. If not, try the UPS store, they notarize for \$7-11 per page. Or, look up a notary in your area.

Checkoff list for notarizing

- I have secured a notary.
  - I have a blue pen.
  - I have a red pen.
  - I have a red ink pad for my thumbprint. Review how to add your thumbprint to your autograph above.
  - My sticky notes are attached to each document so I know what I will be doing.
  - Small package of wet wipes; this is to remove the ink from your thumb
  - Manilla folder 8.5x11
  - I'm ready to head to the notary.

## STEP 6

Remember, notaries ONLY verify your identity. They DO NOT read your documents; this is not in their purview. They are witnessing your signature/autograph and that you are the person on your credential(s).

- Ask if notary can sign in blue
  - Autograph each document as shown on sticky note with thumbprint
  - Use wet wipes so you don't smudge your paperwork. If you have any issues it's really not a big deal.
  - Autographing of documents in front of witness/notary complete.

## STEP 7

**Once Notarizing is Complete**

- Create 3 hard copies of your notarized documents; including your two witness statements for your records.
- Save a copy of the notarized documents on a USB or somewhere you can store safely if there is an EMP. You will use these for uploading on Global Family if you choose to publish for free and get an account.

- NOTE: as mentioned above; you will upload your scanned completed documents to Global Family and at the same time if you decide to mail off originals for publishing with a state of state you can do both at the same time. This will assure you are getting your prosperity account at the same time. - Read the rest of this manual for all information.

## STEP 8

### Publish & Record Your Documents

We, personally, believe it's important to record on a state of state (a county) because this is the system that the federal government uses as record. By using their system to record and publish your declaration as an American and correcting your political status on the record you are serving them notice directly. The goal is to create superior evidence, on the record, and so you'll find 5 different options below.

We will start with Global Family because they are both an International Lawful Land & Soil Recording & Publishing System; and it's FREE. We are very excited about this because it is your conduit into your account with an international trade bank for pre-paid credit and ONLY declared Americans can participate. It acts as an International Lawful Land & Soil Recording & Publishing system, which serves the global community worldwide. Their goal is to assist 8 billion people across the world with gaining access to credit to better lives.

Please note: you may use your notarized forms to upload and enter onto their (Global Family) land recording site

**Make sure you read this section again in its entirety to determine which options you will be using. You need a minimum of 1 and can just get started with Global Family and in the future use a STATE OF STATE option or another option.**

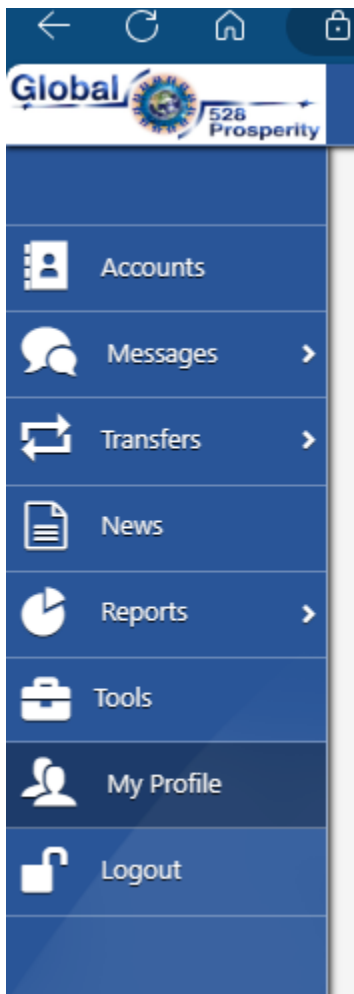
- First Step: Go to 528 Link [528SBDBN \(tgf528.network\)](#) and complete the form.
- Choose the ID you will be using i.e. passport, driver's license etc.
- The GFG# you can leave blank
- For your address you can begin to use % then your address. \*\*However, some systems will not take this format so just do what you can. It's not a big deal unless you are sending a formal letter.
- Under beneficiary you can add whomever you think should be your beneficiary.
- When you have completed the form send an email to [publish@globalfamilygroup.com](mailto:publish@globalfamilygroup.com) and share the something similar to the following:

“I have completed the status correction form and have my notarized documents ready to be published for the first time. My name is \_\_\_\_\_. If you could help me with how to access an account to upload my documents I would be most appreciative.”

**\*\*You will then receive an email once they create your account. Please note this process could take several days to complete as it is first come first serve. Wait a few days and if you haven't heard back, then send another email. The International Trade Bank which is also an International Publishing System is pretty busy at this time.**

Once you receive your account you will have an option to upload each document. You will need a computer for this. If you have scanned all of your documents into one document you may need to upload one at a time. \*\*Pretend you are printing and go to print on your scanned copy then just print the page you want into a pdf and save it. This is an easy way to save into specific pages to upload onto your account. You will also need to upload a utility bill that shows you live at the address you are giving for your account. If you don't have a utility bill in your name you can use the bill in someone else's name and just explain this in the email you will send once everything is uploaded. You will also be able to upload the two passport photos you used for your witness statements. At some point Global Family will be creating free credential cards.

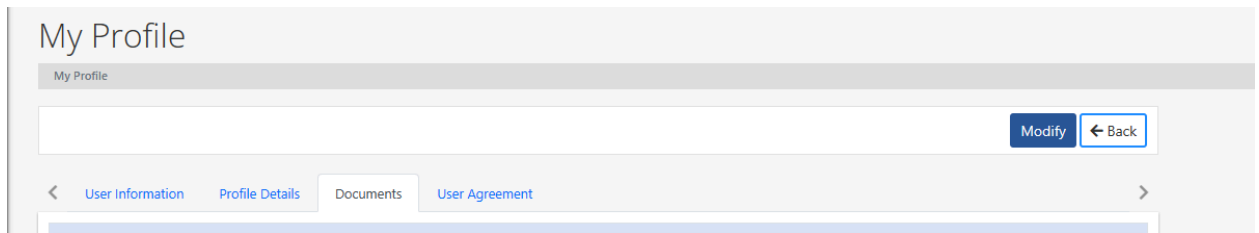
- Make sure to login using this link and save this new link to your computer because this is how you will access your account. [528SBDBN \(tgf528.network\)](http://528SBDBN(tgf528.network))
- You will login by using your email and password they provided you with.
- Look to the right once you are logged in. You will see a list that looks like this:



- Click on my profile.



- You will have 4 areas to choose from. Click on documents as shown below.



- Once you are ready to upload your documents you will need a minimum of the 1779 document, two witness statements, utility bill or bill with corresponding address (if you don't have one review the FAQs below, and your identification that prove you have corrected your political status. \*\*\*Please note: you will see several other places for documents but they are not necessary at this point as for now we are aiming to get your account activated. Once activated you can upload the rest of your docs. If you choose to upload them you can upload in the corresponding upload spaces. For the fee agreement, which is NOT necessary, you can find this in your resources in your bundle and will have to use the word document and add your information and have notarized. Again, we have outlined your minimum requirements above.
- If you want to access pre-paid credit you will need to provide a utility bill, 2x2 photo (at some point they will be creating American State National credentials to their members, and your paperwork.
- Once you are done uploading send another email to [publish@globalfamilygroup.com](mailto:publish@globalfamilygroup.com) and share the following: "Hi, my name is \_\_\_\_\_ and I have uploaded all of my documents and wanted to make you aware just in case I did something incorrectly." In the email is also where you will explain if you don't have a utility bill etc. Then, wait for your account! It will take a couple of days and you will receive an email letting you know.

### Frequently asked questions when creating an account with Global Family

1. Question: I am seeing all sorts of documents including something called a Fee Agreement
  - a. Answer: Remember, above it is stated that the minimum documents needed are your 1779 and two witness statements. The other items listed are for those who are participating in their State Assemblies not for gaining a prosperity account and for publishing and recording.
2. Question: I don't have a utility bill in my name?
  - a. Answer: Make sure to email using the email above and read the below on how to let them know that you don't have a utility bill in your name.
3. Question: I received a password but have no idea how to login
  - a. Answer: Login here [Global-Verify-Login \(tgf528.network\)](http://Global-Verify-Login(tgf528.network)) and enter your full email used and your password.
4. Question: Can I just upload the basics and then add all of the other things later? Like my thumbprint?
  - a. Answer: Yes, we recommend this in gaining access to your account.

More options for publishing & recording below:

- State of State Alaska** (this is where the Federation of States is located and we let them know you have declared yourselves as Americans. They can pull this information up easily for pre-paid credit owed. Plus, we use Alaska for our UCC Filings. There is a traditional recording fee as if you were recording in your own county.
  - Estimate \$100-150 dollars
  - Make sure you list ANCHORAGE on your cover page
  - Drop your documents in the manilla folder; do not include notices
  - Write a note (I wrote mine in pen) to the recording office letting them know that you wish to have your documents and how to reach you via email and phone if there is anything else you need or have missed.
  - Send a check, postal money order (these are best because they can be tracked) or a cashier's check.
  - Because you are mailing your original copies (these must be originals for all counties) Mail certified mail with receipt. This will cost around \$5

# Recording Fees

A. For recording all documents: First page* or fraction thereof	\$ 20.00
B. Each additional page or fraction thereof (same instrument)	\$ 5.00
C. For indexing each name or claim name over six.	\$ 2.00
D. Non standard document fee	\$ 50.00
E. For recording Plats or Surveys	
i. First sheet	\$ 20.00
ii. Each additional sheet same plat (Affidavits, tax status, etc. submitted with initial filing of Plat = No Charge)	\$ 5.00
F. Certification fee, per document	\$ 5.00
G. For conforming a copy of any recorded instrument at time of recording**	\$ 2.00
H. For copying any document by photocopy process	
i. First page or fraction thereof	\$ 1.25
ii. Each additional page or fraction thereof (same instrument)	\$ 0.25
I. Copy of plats, full scale on paper, each sheet	\$ 5.00
J. Copy of plats, full scale on mylar, each sheet	\$ 12.00
K. Images of documents on CD-ROM. Contact us for availability and current fees.	

\* Reference to "page" means one side of sheet; double sided sheets are two pages.

\*\* At the time of recording, a conformed copy is \$2.00 - Any copy made after that time will be charged \$1.25 for the first page and \$0.25 for each additional page of the same document.

- New Mexico** is also an option; based on a previous member of ours. Here is the information. \$25 for New Mexico and \$58 for the e-filing company use the link for the website [irecord365.com](http://irecord365.com)...
- Your county.** Is identical to the process notes above for Alaska. But some counties do not accept paperwork; not all states have true land recording offices and your name is considered land which is why we recommend the State of Alaska.
- Registered Letter:** Send a registered letter to yourself with your documents. Keep the green card as that number is your record number. Use it if ever in court as it is a valid record. **Do not open** until you give it to the judge. \*We have never done this ourselves but it has been recommended.
- Newspaper Ad:** Post an ad in the newspaper claiming yourself as a newly declared American. We do not offer any further advice other than what we have. You can use any magazine or newspaper large or small.

Just a couple sentences will do (no need to provide any paperwork at all), for example: "The Trade Name "William Henry Doe" has been returned and re-conveyed to its natural permanent domicile on the land and soil of New Hampshire effective March 2nd 1950; Doe, Wm. Henry, Fiduciary, in care of 4109 Fairfield Street, Oxford Massachusetts, 01540."

By serving Notice on the Courts, running an ad in the newspaper, recording your status declaration in the land records of the land recorder's office, etc., etc., serving notice on the corporation's "Secretary of State", faxing a copy of your declaration to the local police and Public Safety Offices, etc., they are no

longer free to presume anything about you or your political status, whether or not they issued a Birth Certificate in your name.

## STEP 9

### Wait until you are published and recorded!

The below documents will **NOT need to be notarized**. You will ONLY need to send a copy of your Political Status Declaration to the Secretary of State Blinken. All other letters are sent as they are without any additional information

These letters must be signed with your by: \_\_\_\_\_ (your By line) and you can use your thumbprint as well.

- Scan your signed copies and keep your originals. Autograph your letters with copyright and All Rights Reserved Without Prejudice.
  - Send registered mail or USPS with tracking, save your receipts, and put together with green cards, or proof of tracking, once they are returned for your own records/record keeping.
- 
- \*\*For Veterans: Form DD2168 (this is yours to fill out since it requires an SSN) letting your commanding officer know you have reclaimed your birthright political status
  - Voter Registration Cancellation
  - Revocation of election to pay taxes for IRS and
  - Revocation of election to pay taxes for Internal Revenue Services, both.
  - Bank letter denoting lawful money (if we don't have your information; we will send you the notice that you can complete on your own).
  - You can create your own letters and notify anyone you'd like as listed above at the end of the publishing information.

## STEP 10
